## <u>Provision of Essential Legal Services – End of Life Directives</u> <u>COVID-19 (Coronavirus)</u>

The recent COVID-19 pandemic has raised immediate concerns for people of all ages regarding plans for surrogate healthcare decision-making, advanced directives for end-of-life care, and estate planning to ensure adequate protection of assets. Buncombe County recently issued a "Stay at Home" order for county residents, effective Thursday, March 26, 2020 at 8:00PM through April 9, 2020 at 6:00AM requiring residents to stay in their places of residence. However, individuals may leave their residences and travel throughout the County in order to access, among other things, certain "Essential Services." **One service expressly permitted by the Order is "legal services ... necessary to assist in ... end of life directives."**
